
CRUISE AND BUFFET

FROM THE BOARD ROOM



Thank you for your faithful stewardship to the community of Christ

Over the past months several persons have shared their input on operational matters in Wesleyan Village. One comment that a few have made goes a bit like this – "It seems that you are trying to run the Village like a business." To that we reply, "Thank you." *Maybe* you intended it as a criticism, but we received it as a complement. We are encouraged that people are taking notice.

There are one million three hundred thousand reasons (\$1,300,000) why we need to run Wesleyan Village in a business-like manner. That's the amount of God's money entrusted annually to the Board to operate an active adult Christian community. More importantly, there is one reason – *stewardship!* We have a responsibility to exercise faithful stewardship of the resources God has entrusted to us.

This community has an excellent record on stewardship. As individual members you faithfully pay your assessments and contribute above and beyond to the ongoing work of God's kingdom in this community. Our assessment collection rate is among the best in the nation. Thank you for your faithful stewardship. You are indeed deserving of our gratitude.

It can be confusing, however, when persons seem to think that running the Village in a business-like manner and operating a Christian community are somehow two incompatible actions. Why must we choose between the two? Operating a Christian community requires that we are good stewards and function based upon the soundest of business principles.

Good stewardship is a primary responsibility of your Board of Directors. A part of that stewardship is consistency of application of governing documents. Attorneys who specialize in Community Association law have made it clear that a major problem in community associations is inconsistent enforcement of rules. Over the past year, we not only revised our Governing Documents (approved by the General Board of Administration of The Wesleyan Church), but we have written and/or revised twenty-seven (27) Policies, eight (8) Operating Procedures, eleven (11) Job Descriptions, and thirty-six (36) Forms/Letters and counting. These have been placed into a Governance Manual. This is part of our effort to bring consistency to the operating of Wesleyan

Village – so that everything might be done decently and in order. We share this that you may grasp the importance of what we have spent a significant portion of our time on over this past year.

Will we continue to run Wesleyan Village in a business-like manner? We really have no other choice. When Dr. P.F. Elliott signed the original Certificate of Incorporation in 1971, he incorporated us under the laws of the state of Florida as Wesleyan Bible Conference Association, Inc. According to that document we are a "place of business" pursuant to Florida Statutes. We are subject to the governing authorities (Romans 13:1). We will remain faithful to our founder's intent. The better stewards we are, the healthier Christ-followers we become. Operating in a businesslike manner is fundamental to being a Christian community.

Assessment Notice

As previously announced (Community Coffee - March 18, 2022), the Board of Directors voted to increase the monthly reserve assessment for the Waste Water Treatment System from \$5.00 per month to 10.00 per month. Beginning October 1, 2022, everyone who pays an assessment will be billed an additional \$5.00 per month for this cost.

In addition, owners in Shepherd Courts and in the Life Lease Units will receive an increase in their specified reserve fund beginning October 1, 2022. Shepherds Court will increase by \$5.00 per month and Life Lease Units will increase by \$15.00/\$10.00 per month. These increases are necessary to move toward full funding of these reserve funds.

No Board decision has yet been made regarding any increase to the Base Assessment for 2022-2023. The Base Assessment has not been raised since March 1, 2021. Any increase to the Base Assessment will be announced at the Community Coffee on September 23, 2022. As of now, the total assessment increases effective October 1, 2022 are:
